## INSTRUCTION for AUTHORS of JOURNAL of HARRAN UNIVERSITY FACULTY of VETERINARY MEDICINE\*

- **1-** The Journal of the Faculty of Veterinary Medicine, University of Harran (Harran Univ (HRU) Vet Fak Derg) publishes original clinical and experimental research, case reports, reviews, preliminary report and Letters to Editor concerned with all aspects of veterinary sciences in Turkish and English.
- The journal is published as 2 issues per year. There is no publication charge.
- **2-** Papers are accepted for publication on the understanding that they have not been published and are not currently considered for publication elsewhere. All responsibilities from published articles merely belong to the authors. No copyright fee is paid to authors.
- **3-** In frame of the respect to ethical principles, Harran University Journal of the Faculty of Veterinary Medicine makes preliminary evaluations of all articles and case reports for plagiarism by using the program "ithenticate" made available by TUBITAK ULAKBIM to all universities. Therefore similarity index of the articles, case reports or reviews should not exceed 23% (Turkish abstract, abstract and references are excluded). When the similarity index detected via "ithenticate" program exceeds 23%, the articles case reports or reviews sent to our journal for publishing will not be further evaluated and returned to the author.
- **4-** Ethical responsibility of all research submitted to the journal for publication belongs to the author(s). However, the Editor reserves the right to ask author(s) for an approval letter given by local ethics committee.
- **5-** If the paper is accepted for publication the Copyright Transfer Agreement Form should be signed by all co-authors and the scanned form should be sent to the Editor by e-mail before publication. The article will not be published until the Copyright Transfer Agreement Form is received.
- **6-** Submission to Harran University Journal of Faculty of Veterinary Medicine proceeds on-line through Dergipark by using the link http://dergipark.gov.tr/huvfd.

## **Preparation of Manuscript**

Papers submitted for publication should be written using MS Word 2007 or upper version in Times New Roman style, 12 font size, 1.5 line spacing and 2.5 cm from all margins. Original papers and reviews should not exceed 15 pages and case reports should not exceed 5 pages including tables, figures and graphs.

International Standard Unit (SI System) should be used for units and abbreviations.

Research Articles: Original research articles should be lined up as; Heading (Turkish), Authors names (corresponding author should be remarked with (\*), authors addresses, Abstract (Turkish) and Keywords (Turkish) (3-6 phrases), English heading, Abstract (English) and Keywords (English), Introduction, Materials and Methods, Results, Discussion and Conclusions, Acknowledgement and References. If the paper is written in English; firstly English heading, author(s) name(s), author(s) address(es), Abstract (English) and Keywords (English); Turkish heading, Abstract (Turkish) and Keywords (Turkish) should be lined up and the rest of the article should be in English. Tables and Figures should be printed on separate pages.

## Writing order:

**Abstract:** Abstracts should not exceed 250 words in original articles and 200 words in other kind of articles.

**Keywords**: Keywords should be 6 at maximum and written at the bottom of the summaries in both languages. Keywords should be chosen from Turkish Scientific Terms. These terms can be obtained from internet address of Turkish Scientific Terms (http://www.bilimterimleri.com).

**Introduction:** This section should supply pertinent background information for understanding and interpretation of the results the hypothesis and the aim of the study should be clearly given at the end of this section.

**Materials and Method:** This section should describe the experimental procedures in sufficient detail to allow other scientists to repeat the experiment. Where techniques that have already been described in an indexed journal are used, this section may be concise and only provide relevant references. For studies requiring an approval of ethics comittee, informations on the name of the ethics comittee and the date and the number of the approval should be given in this section.

**Results:** The results section should provide data that are concisely explained, when required by including tables or figures.

**Discussion:** The results of the study should be discussed based on the literature and the importance of the findings should be stated. This section should be finished by concluding statements.

**Acknowledgements:** Any additional information concerning funding and personal contributions to the study or manuscript should be noted.

**Reviews:** Review articles aim to provide accessible, authoritative overviews in a field or topic. Harran University Journal of Faculty of Veterinary Medicine considers only invited reviews for publication. Reviews must contain following sections; abstract, introduction which can include sub sections, conclusions and references.

**Case reports:** Author(s) must prefer rare and original cases include scientific point of view. Case reports should not exceed 5 pages (excluding title page), and should not use more than 15 references. Case reports should include "Abstract, Introduction, Case, Results and Discussion as well as References" sections.

**Short Communication:** Short Communications should concisely presents results of a limited investigation they should be prepared in the form of original articles and not exceed 5 journal pages including figures, tables and references. They should include at most 2 figures and tables.

## References

All references in the text must be given by author's surname and year of publication enclosed in round brackets [Example: Adams (1998) reported that...; Wilkie and Whittaker (1997) reported that..., Doyle et al. (2007) reported that... or It has been reported that... (Adams (1998)'; It has been reported that... (Doyle et al., 2007)]. Citations should be arranged in alphabetical order and then chronologically. [Example: It has been reported that... (Adams, 1998; Adams, 2008; Doyle et al., 2007; Wilkie and Whittaker, 2006)]. Publications by the same author(s) in the same year should be identified with a, b, c after the year of publication. [Example: It has been reported that... (Adams, 1998a; Adams, 1998b)

Web address should be referenced as anonym. For example Anonym 2010. Only official web pages should be used

**Tables and Figures:** Tables and Figures should be printed on separate pages. Each table and figure should have a brief and self explanatory title and should be consecutively numbered with Arabic numbers. The text should include references to all tables and figures. The title of each table should be written above the table. Abbreviations and explanations used in the table should be placed at the bottom of the table.

Photographs should be of high quality. If manuscript is submitted by electronic mail, images must be scanned in a resolution of at least 600 dpi and submitted in JPEG or TIFF format. Offprints of the journal will be in black and white.
